## Modelo contrato privado entre particulares

Diferentes tipos de contratos y escritos existen para diversas operaciones, como compraventa y arrendamiento de propiedades, incluyendo viviendas, locales y vehiculos. Estos escritos están diseñados para ser utilizados entre particulares, trabajadores o empresas. Algunos ejemplos son: \* Contrato de Arras para Compraventa de Vivienda \* Contrato de Alquiler de Vivienda y Local \* Escrito para Notificar el Desalojo al Inquilino por Necesidad de Vivienda Given text: desea un modelo de contrato entre empresas o profesionales con características especiales no dude en consultarnos, haremos uno a su medida. En esta ocasión un conjunto de plantillas para uso particular, de diferentes temas y que cubren gran parte de reclamaciones, deudas y solicitudes para dejar por escrito antes la otra parte peticiones relacionadas con los contratos ya establecidos, o en su caso, para comunicar a entidades o empresas hechos que son de interés. Solo debe ir al escrito que desea y descargarlo. En cada uno se explica su contenido, para confirmar que es lo que precisa. Los contratos privados entre particulares son documentos legales que reflejan las voluntades de las partes firmantes. Es válido entre ellos, sin efecto frente a terceros. Se recomienda incluir cláusulas protectoras y registrarlos en casos como préstamos. La elección entre contrato privado y escritura pública, que es un documento público, depende del tipo de operación y ofrece mayor seguridad jurídica. Este es un contrato privado entre las partes, que establece los términos y condiciones del acuerdo entre ellas, regulando sus obligaciones y derechos en relación con su relación contractual. El objetivo principal de este contrato es regular las condiciones bajo las cuales se llevará a cabo el acuerdo entre las partes. \*\*Private Loan Agreement\*\* This agreement has been in effect for [X] years from the date of signature, with the option to extend or terminate by mutual agreement between the parties. \*\*Clause 4: Dispute Resolution\*\* The parties agree to try to resolve any disputes through direct negotiations and, if necessary, use an alternative dispute resolution method. If signed on [City], [Date]. \*\*Agreement Details\*\* On [Date] at [Location], [Party 1 Name], with a permanent address at [Address], phone number [Phone Number], and ID [ID Number], and [Party 2 Name], with a permanent address at [Address], phone number [Phone Number], and ID [ID Number], both parties agree to enter into a non-interest-bearing loan agreement, governed by the following clauses: \*\*Clause 1: Loan Terms\*\* [Party 1] has already lent [amount in euros] to [Party 2], which is acknowledged as received. \*\*Clause 2: Interest-Free Loan\*\* During the loan term, the borrowed capital will not accrue any interest. \*\*Clause 3: Repayment\*\* The borrower must repay the loan within a maximum of [timeframe]. The lender may accept early repayment at any time. \*\*Clause 4: Payment Method\*\* Payment will be made through [payment method], and the lender will issue a receipt upon payment. \*\*Signature\*\* Both parties sign this agreement in triplicate, as proof of their consent. Note: For the loan to be considered interest-free, it must explicitly state so in the contract. Additionally, three copies of the contract and the corresponding tax form must be submitted to the Comunidad Autónoma (or Registro de la Propiedad for smaller towns) with a mention of exemption from ITP taxes (article 45.1.B, RDL 1/93). It is also recommended to keep additional proof of the transaction (e.g., bank transfer records, payment certificates). According to the agreement between the parties mentioned, the aim is to regulate their contractual relationship in accordance with current legislation. Clause 1: Purpose of the ContractThe present contract aims to establish the conditions under which [description of activities or services] will be carried out. Clause 2: Rights and Obligations of the PartiesThe parties commit themselves to:a) Fulfilling the obligations stipulated in this contract;b) Providing accurate and complete information about their capabilities for fulfilling the contract's purpose; Clause 3: CounterpartThe parties agree that the counterpart for services will be [amount or description of payment], payable in [payment method] on agreed-upon dates. Clause 4: Contract DurationThis contract will have a duration of [number] years/months, starting from [start date] and ending on [end date], unless renewed by written agreement. Clause 5: ModificationsAny modification to this contract must be made in writing and signed by both parties. Unwritten modifications will not be valid. Clause 6: Conflict ResolutionThe parties agree that any dispute arising from this contract will be resolved through mediation.
